JOINING BY VIDEOCONFERENCE:

1. The September 3, 2020 Civil Service Commission (CSC) Meeting may be accessed through Zoom online at <https://smcgov.zoom.us/j/96502481077>. The meeting ID: 965 0248 1077.
 - You may be asked to enter an email address and name. Please identify yourself by name as this will be visible online and will be used to notify you that it is your turn to speak.
 - We will use the “raise hand” feature in order to organize any public comments.
 - When the Chairperson of the Commission calls for the item on which you wish to speak, click on “raise hand.” The CSC staff member Elvia Gonzalez will activate and unmute speakers in turn. Speakers will be notified shortly before they are called to speak.

- Press *6 to mute and unmute your phone
- Press *9 if would like to speak.
- When the Chairperson of the Commission calls for the item on which you wish to speak, click on Press *9. This will notify the CSC staff member Elvia Gonzalez that you would like to speak. When you hear your name called, Elvia will unmute your mic to begin speaking.
